

# Filming and photography on airport

---

## Terms and Conditions

**Northern Territory Airports (NTA) consists of Darwin International Airport (DIA), Alice Springs Airport (ASA) and Tennant Creek Airport (TCA). The following Terms and Conditions have been set to ensure the safety and security of everyone on airport and to minimise the impact of filming and photography activity on airport operations.**

An application for permission to film and or photograph at DIA, ASA or TCA must be sought at least five working days before the event. Applicants must include a copy of their Certificate of Public Liability Insurance of \$20 million or greater. Applicants wishing to film and/or photograph an airline or its staff must consult and obtain permission from the airline before proceeding.

If an application is successful, a Location Release will be issued which must be kept with the crew at all times while on location. Filming and photography activity must give consideration at all times to passengers, tenants and airport staff, must not interfere with the flow of airport traffic and must not disrupt airport operations.

NTA may decline, defer or terminate an application at any time for security, safety or operational reasons or if incorrect or misleading information is provided to NTA. If these terms and conditions are not strictly adhered to, NTA may require an applicant to leave the premises forthwith. NTA will not be responsible for any loss or damage accruing to an individual or organisation as a result of changes to or termination of, the activity.

### Safety

Applicants must operate in a clean and tidy area while on airport. Filming and photography must only occur in the location(s) and for the purpose specified in the application. A safety plan must also be submitted if persons other than the film crew wish to enter the filming area. Applicants' accessing DIA, ASA or TCA do so at their own risk and release NTA from liability for any loss, damage or injury of any kind.

### Security

Applicants are subject to airport security access controls and screening and may be asked for photo identification. Filming and photography of, or within:

- (a) any airport security facility or equipment,
- (b) Customs Controlled Areas; or
- (c) Australian Defence Force facilities (south of the runway at DIA)

is **strictly** prohibited.

Requests to access airside will be subject to Airport Security Identification Card (ASIC) and Visitor Identification Card (VIC) requirements; screening and enhanced security. Fees may be charged to an applicant if escorts are required.

### News Media Crews

News crews are required to notify NTA of their intentions before arriving at the airport. Crews will be assisted wherever practicable; however, they must follow the directions of airport staff at all times. NTA has the right to ask Crews to leave the premises for safety, security or operational reasons or if these Terms and Conditions are not strictly adhered to. News crews are required to submit an Insurance Certificate once every calendar year to maintain access to NTA.
